DOSSIER:

- Bryl Maiia Petrivna - wife of Bryl Kostyantyn Ivanovych - the Head of Zaporizhzhya Regional State Administration(as of May 2018).
- Kostyantyn Bryl is the co-founder and head of NGO Kyiv Regional Civil Union "With Trust in Ukraine", registered in Pereyaslav-Khmelnytskyi. Another co-founder of the NGO "Kyiv Regional Civil Union "With Trust in Ukraine" is Radevych Vitaliy Fedorovych. The same Radevych Vitaliy Fedorovych is the head of Hunting paths LLC, share of 22,6% of its authorized capital belongs to Bryl's wife, Bryl Maya Petrivna. In February 2004, Kyiv Regional Council gave

Hunting Paths LLC 49 thousand hectares of land for use in Vyshgorod District of Kyiv Region for the term of 25 years. Hunting Paths LLC concluded a contract with Kyiv State Forestry Union Kyivlis on conditions of running hunting farm on the provided lands. Later this contract was revised twice in 2007 and 2013. In 2016, Prosecutor's Office filed a lawsuit to recognize the decision of Kyiv Regional Council illegal and cancel it as well as to recognize the contract on rent of lands invalid. The reason was that not all owners of lands have given consent to use their lands for hunting. The court of first instance proved that letters of a number of village councils of Vyshgorod district certifying their consent to provide lands for use to Hunting Paths are absent. Additionally, some village councils violated the order to provide such consent. Thus, the court agreed that the decision of Kyiv Regional Council on providing lands to Hunting Paths was illegal. However, the court rejected the claim because of violation of period of limitation. On 15 November 2017, Supreme Economic Court of Ukraine in cassation instance returned the case for a new trial. It's interesting that in Vyshgorod district of Kyiv region there is also Hunting Paths II LLC (EDRPOU 35783722). The head of Hunting Paths II LLC is Buzyak Oleg Anatoliyovych, he also has signature rights in Hunting Paths LLC.
