

Dear Mr. Krasnitski,

I appreciate your decision to retain me to provide media relations consulting. This letter lays out the terms of service for the agreement between ITBC LLC (the Client) and Naomi Decter Munson (the Consultant).

- The agreement will extend for a twelve-month period, beginning on August 15, 2018 and ending on August 14, 2019. It may be renewed by mutual agreement.
- Consultant will provide counsel to the Client and any of its representatives concerning appropriate and effective means of increasing through media relations awareness in the U.S. of reform in Ukraine.
- Client will pay Consultant \$15,000 US per month. Payment for the first and last months, in the amount of \$30,000, will be due upon signing of the agreement.

- Consultant will abide by all U.S. laws governing media relations.
- Client will hold Consultant harmless in any loss or legal action arising from actions by Client.
- Consultant will hold Client harmless in any loss or legal action arising from actions by Consultant.
